8. **Descriptions of prerequisites** (from the university catalog) if not on the syllabus
9. Evidence that you earned **graduate credit** for the course (this sometimes requires documentation of the course numbering system, which not all institutions provide with transcripts)
10. **Certification** by the other institution that the course was not used towards an undergrad degree nor toward a Master's Degree, if transferring a course to be used on a MS plan of study

* If on a quarter system, note that one quarter-hour is approximately equivalent to 2/3 semester-hour
